Discussion was held to have coapprove from CCC and maybe WCHA, but Oregon CHA would produce. Discussion was held that Oregon CHA can't produce show outside of Oregon, this is a rule only and can be voted on by board. **Tania/Fiina motion/second for Cameron, Josh, and Scott move forward to gather more information to bring back to the Board for approval.
